V. PAYMENT SCHEDULE

Vendors may not source more than 15% of the products from another grower/seller to ensure the market maintains a fair and equitable selling environment for all vendors. These vendors may not sell any commercially-sourced items.

Vendor Type: Commercial
Vendors selling non-food products not produced by the vendor (e.g. home-based businesses such as Avon and Tastefully Simple). Vendors selling product that is 85% commercially sourced—not grown/raised by the vendor. Vendors selling any combination of the above categories for the market will be charged the Commercial Vendor fee.
